# The discounted Deutschland-Ticket with Hessenpass mobil



## Discounted travel with the Hessenpass mobil

With a proof of eligibility – the Hessenpass mobil – you can subscribe to a particularly low-priced Deutschland-Ticket for a maximum of 12 months. The ticket entitles the holder to use 2<sup>nd</sup> class public transport not just in Hesse, but throughout Germany.

The Hessenpass mobil is available to all residents of Hesse and those who

- ▶ receive citizen's income (Bürgergeld),
- ▶ receive housing allowance (WohngeldPlus),
- ▶ receive social welfare (Sozialhilfe),
- ▶ are asylum seekers.

The Hessenpass mobil is automatically sent to all eligible persons by the local office responsible for this. When you are buying the discounted Deutschland-Ticket, you have to present the Hessenpass mobil.

## € Mobile for 1.02 € per day

The discounted Deutschland-Ticket with the Hessenpass mobil costs

- ▶ 31.00 € per month by subscription.
- This way you are mobile throughout Germany for 1.02 € per day.



## Mobile throughout Germany

The discounted Deutschland Ticket is a subscription and is valid for 12 months.

The ticket is valid in the 2<sup>nd</sup> class of all buses, trams, underground and suburban trains and on local and regional trains. It is not valid for long-distance transport, e. g. ICE, IC, EC.

It is valid for one person and cannot be transferred. Children under 6 years of age can travel free of charge. Additional persons cannot be taken along; they will have to buy a separate ticket.



## Your way to the ticket

The discounted Deutschland-Ticket can be ordered on the first day of the any month you wish and it is then valid for 12 months.

The discounted Deutschland-Ticket can be purchased through the order form enclosed.

You can also find the order form online at [www.vrn.de](http://www.vrn.de). You can fill this out online. The order form has to be printed out and signed.

Please enclose your valid proof of eligibility, Hessenpass mobil, with your order form.

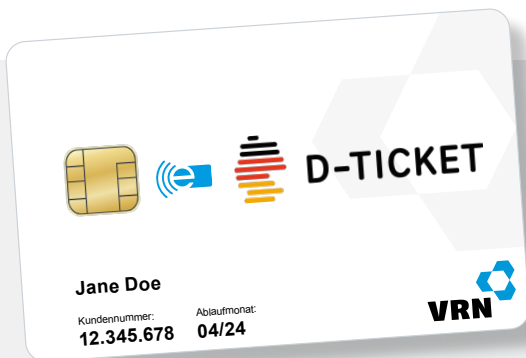
Send the order form together with your valid proof of eligibility Hessenpass mobil to your transport company. You will find the address on the order form.

Your order must reach the transport company by the 10<sup>th</sup> of the previous month so that it can be valid on the first of the following month.

You will then receive your discounted Deutschland-Ticket by post.

Payment is only made by SEPA direct debit through a bank account with a charge of 31.00 € per month each.

Direct purchase at a sales agent and cash payment are not possible.

# Your advantages at a glance

## Price:

31.00 € per month by subscription

## Eligible group:

Persons holding a Hessenpass mobil proof of eligibility. This is available to all residents of Hesse and those who

- ▶ receive citizen's income (Bürgergeld),
- ▶ receive housing allowance (WohngeldPlus),
- ▶ receive social welfare (Sozialhilfe),
- ▶ are asylum seekers.

## Ticket model:

subscription to the discounted Deutschland-Ticket, co-financed by the State of Hesse

## Validity:

Start on the first of every month, duration 12 months by subscription, after which a new proof of eligibility has to be submitted.

## Coverage:

across Germany in 2<sup>nd</sup> class on local and regional transport (not for long-distance transport, e. g. ICE, IC, EC)

## Transferability and rules for taking others along:

personalised and non-transferable, you cannot take additional persons along

## Output format:

as an e-Ticket on a chip card (transitionally as a paper ticket)

## Purchase options:

can be ordered by post with order form + proof of eligibility Hessenpass mobil, no direct purchase and no cash payment possible at the sales agent

## Payment:

only by SEPA direct debit

## Issue of a SEPA direct debit mandate for recurring payments

I agree that my data will be stored and processed by the contracting company for the purpose and for the duration of the contract, in compliance with the data protection regulations (Art. 6 and 13 EU-DSGVO). I authorise the transport company I have chosen to collect the monthly instalment for the discounted Deutschland-Ticket with the Hessenpass mobil from my account by SEPA direct debit, until further notice. At the same time, I instruct my bank to honour the SEPA direct debits made by the contracting company to my account. I can demand reimbursement of the debited amount within eight weeks, starting from the date of debit. The conditions agreed with my bank shall apply. If the contracting company already has a valid direct debit mandate from me, the transport company can assign further contracts to the existing mandate. The mandate reference number remains unchanged. The contracting company reserves the right to carry out a credit rating check. For this purpose and in the event of insolvency, your data will be forwarded to a credit bureau.
